Character, Crimes and Injustices by Rajinder Rana and Family

To,

My name is Arun K Singh. My son, Atharva K Singh, was illegally kidnapped (per IPKCA, laws of USA), on April 9th, 2021, by Meghna Rana with support from conspirators Rajinder Rana and Vandana Rana. Even after more than 850 days of illegal captivity, child is being held against my wishes. I am challenging the very corrupt Rana family to answer these questions below, in recorded and public view. These are very simple yes or no questions. By the time these are answered, it will be very clear the extent of torture, lies, corruption, fraud and evil this abusive family is capable of. I have requested it numerous times privately and each time the family bypass them. There is no sign of this corrupt and law abusing family ever stopping in its injustices. While I am no mercy of their permission to retrieve my son, I have committed myself to bringing the true face of this family to surface and alerting society about evils lurking around us.

These are the questions, to which if answered by Meghna Rana and family, will expose the truth. I am subjecting myself to answering same questions in front of a lie detector, in full public view. My answers are provided here, Meghna Rana should record her response. I am asking anyone who reads this document to ask anyone in this family to be subjected to these questions and ask them to return the child.
