OF INDIAN PENAL CODE, 1860**

**MOST RESPECTFULLY SHOWETH:**

1. The Complainant, Arun Kumar Singh, filing following complaint against Mr. Rajinder Rana for the alleged offences of kidnapping, criminal intimidation, assault, grievous hurt...
2. That the Complainant is a victim of multiple tortures and offences by the Respondent and his family.
3. That the brief facts in the present complaint are such, the marriage of Complainant with Mrs. Meghna Rana (daughter of Respondent) was solemnized on 25<sup>th</sup> November 2015 in Prayagraj (previously known as Allahabad), Uttar Pradesh. The marital union was the result of fraudulent misrepresentations by Mrs. Meghna Rana and Respondent about the nature and character of Mrs. Meghna Rana and Respondent/accused. The accused

family is willing to commit fraud, kidnapping, torture, and abuse for the purpose of illegal and immoral monetary gains.

4. That the Complainant resided in Prayagraj for only about a week after our marriage. That Complainant expedited the VISA formalities and Mrs. Meghna Rana thereafter left for United States on 15<sup>th</sup> December 2015. That the parties started residing in United States since then until separation on 9<sup>th</sup> April 2021. That they were blessed with a son on 14<sup>th</sup> February 2018 namely Atharva Kumar Singh, who was born in Jacksonville, Florida, USA. The minor child, by virtue of being born in USA, is an American Citizen. The relevant birth certificate in support of the same is attached herewith as **ANNEXURE-P1**.
5. That it is pertinent to note that in the year 2016, on 14<sup>th</sup> November Complainant along with his wife came to India and stayed together in Prayagraj in his matrimonial house for about two weeks. That my wife (Mrs. Meghna Rana), despite having a good life in matrimonial house, was pressed to return and stay at accused's home so bonding with new family could not occur. She stayed there till 09<sup>th</sup> February 2017 after which we flew back to United States.
6. That please appreciate that after the birth of our son, the mother of my wife i.e., Mrs. Champa Rana came to live with us for few months. That during those months, my mother-in-law had mentally and physically assaulted me couple of times over trivial issues. In one of the serious incidents Mrs. Champa Rana hold her hand against my throat i.e., strangulate me in an apparent attempt to kill me. This was the result of a trivial matter where I had displayed some concerns for infant child not being put on his mittens for his protection. Out of courtesy and mercy, and with some hope in of rectification of her ways, I hesitated reporting this to police for the fear she would be arrested in a foreign country. Numerous texts were exchanged with my wife

afterwards and in one of the text my wife has accepted Ms. Champa Rana assaulted and strangled me. The relevant text/message/chat in support of the same is attached herewith as **ANNEXURE-P2**.

7. That during my relationship with Mrs. Meghna Rana, Complainant had to give in to demands of monetary and non-monetary both. That in one such incident that took place on 8<sup>th</sup> April 2021, my wife called 911 and made false statements in front of the Police officers. That after a meditative thought she stole the script right out of notorious George Floyd incident and claimed that the I did to her what convicted police officer did to Mr. Floyd. That she gave false statement under oath that the I stepped on her 'neck' and caused obstruction to her breathing. She made series of false statements, one after the other. That evidence of her falsehood can be provided to support the same. Tired of COVID induced difficulties and always too greedy of easy and luxurious life, my wife abused federal and state laws and perjured in front of New York state police officers and with full blown conspiracy by other accused and ran away to India with my minor on 30<sup>th</sup> April 2021. Court and police officers found my wife's statement false and designed to frame someone and hence an investigative case was ordered against her. That she despite being aware of the investigation, have been hiding behind jurisdictional barriers, and never provided any cooperation in the investigation. That Meghna Rana very cruelly and narcissistically not only subjected me to mental and psychological torture through her falsehood and crime of perjury, but she also stole my son to hand over to greedy accused.
8. That it is apt to mention that two domestic incident reports were filed, within 24 hours. First incident report was filed with Officer Dana Kapuscinski afternoon of April 8<sup>th</sup>, 2022. That my wife contacted one of hotel staff to reach

out to me that my wife is abandoning hotel overnight, and I should immediately take over. That please note that Hotel is where I was living at the time, and it was also my place for business. That my wife tricked and when he arrived, she again called police and filed second incident report with Officer Daniel Hanson. That she has given contrary answers in these two reports to the same set of questions put forth by the officers. That she was attended by medical professional who described her physical injury as her face being red as only unusual condition. That importantly, after filing false complaint, she immediately left the country to avoid any consequences emanating therefrom.

9. That please note that my wife ran away with the child to India, mainly due to the fear of being caught for her lies and prosecution. That please note that transportation of American child across the country without my consent and without a court order is a federal criminal offense. That my and in common intention with Respondent/Accused not only kidnapped my child, but they have also held him in illegal custody against my will for last more 3 years. That my wife under brain washed by Respondent/ accused made huge demands to ransom money using my child as the leverage, which is nothing less than extreme mental trauma and harassment caused by her and other accused. That shockingly the Respondent has demanded a whopping amount of Rs. 50 Lacs in exchange of the child. Their demands have continued numerous times despite me facing business bankruptcy in United States. Any funds sent for the welfare of the child was not spent on him. That many a times, the Complainant has tried to give in to the demands of accused for the sake of his child. That relevant transaction proofs can be provide at a later stage.

10. That it is important to note that in June 2016, during one of the arguments, my wife physically assaulted me, by deliberately twisting my small hand finger tilting it to 90 degrees therefore resulting in its fracture. That my wife has depicted her violent behavior in past, resulting in other physical injuries. None of the incident resulted in even a scratch to her. That the photographs showing the smashed finger is annexed as **ANNEXURE -P**. That Complainant was hospitalized and a surgery on his hand was performed. Metal pins were inserted in my hand and removed many weeks later. Given that my trade involved typing, this incident made huge impact. That Complainant was even prohibited from driving. However, my wife continued to force me to drive for every matter requiring driving, including driving more than 1500 Kms from Jacksonville to the Hotel with fractured hand. That in support of the injury Complainant am annexing the Hand Surgery Report from Erie County Medical Center, St, Buffalo, New York. That copy of the Surgery Report is annexed as **ANNEXURE -P**.

11. That in July 2019, my wife again in a fit of anger bit my left-hand area where thumb meets hand with full force until hand started to bleed and almost repeated her previous act of atrocities towards me. I wanted to go talk to my parents which my wife did not approve of. While trying to leave the Scene of argument, my wife pulled me towards her and used her mouth to bite with extreme force and duration. Blood was gushing out and bones could be seen from deep wound. That she then pressured me heavily to not seek any medical attention as she recommended wound to heal by itself. Complainant escaped the day from the cruelty and drove me to emergency Section at hospital in Westfield, New York. That Complainant is annexing medical report from Allegheny Health Network where he went for treatment. The same is annexed as **ANNEXURE -P**. That she has not only caused immense physical harm to

me, but she has inflicted emotional, mental, verbal harassments in the past upon my parents.

12. That one day argument started with Respondent/Accused, wherein he threatens to falsely implicate Complainant's entire family, my wife proceeded with kicking me with her legs violently and vigorously. Complainant asked numerous times on the reason for assault, or why Respondent/Accused threatened to falsely implicate family, my wife could not provide any reason. When Complainant prompted to call police, my wife pleaded emotionally to not do so. Even though Complainant ended not call police having mercy on her, a nearby residents to other room in hotel called police which my wife misunderstood to have been called by the me. For the fear she would be thrown in jail, I did not divulge any details of assault to police at that time.

13. That it is pertinent to note that my wife has always shown a brutal and agitated attitude towards me since the inception of their marriage. Her interest and that of Respondent/Accused has always been eventual monetary gain from the relationship. That there have been innumerable instances of physical, verbal, and psychological abuses by her upon me which existed till our separation. That there have been instances of inhumane behavior wherein she burnt my legs by pouring hot cooked lentils, inflicted head injuries so on and so forth. The I am annexing a photograph whereby head injury inflicted by Respondent upon the is evidently visible for the perusal of the Court. The same is annexed as **ANNEXURE -P**.

14. That it is pertinent to mention that between a short period of April 2021 and March 2022 total of INR 21,51,658 of martial funds were transferred without my consent. That my wife made a demand for Rs.50 Lacs for the child and Rs. 50 Lacs for herself "I want Rs 50 Lacs for myself and Rs 50 Lacs for the child and I know you fucking have it" – said my wife demanding money. That

the Respondent/Accused controlled my wife like a puppet, and abusing law with full support and backing by Ms. Vandana Rana (who happens to be sister and lawyer), continue demanding my parents to travel to Chandigarh so the extortion demands can be made in person, and so that no record should exist of any such demands and transaction. Numerous text messages evidence of such coercion is available.

15. In financial year 2020 when I was raising my minor child with my wife, our hotel business was heavily struck by pandemic and income tax return reflects an economic loss of Rs. 20 Lacs. That the Respondent/Accused (Mr. Rajinder Rana) have been on lookout for such opportunities of financial distress to influence my wife to take extreme measures to extract funds and move to India where those funds can be in their control. That my wife, under the influence of law abusing Respondent/Accused, engaged in incessant money extortion techniques USING Atharva as a shield to achieve their objectives. That my wife remit money from USA to India to an account controlled and used by Respondent/Accused for many months. Those transfers accelerated to huge amounts when my wife reached in direct sphere of their influence.

16. That Respondent/Accused has been intimidating me and my family that if we do not give them money, they will implicate false legal cases upon us and will not give custody & meeting rights of my child. That it is germane to mention that my wife had cunningly sneaked the minor son out of my lawful custody and illegally transported my minor child to India without any permission, approval, and agreement on 30<sup>th</sup> April 2021. Further torture was caused when I was not allowed to have appropriate access to my child. Please note that my son is a United States citizen and not India citizen still she has caused immense mental and psychological trauma by detaching & parting me from my only son. That such a conduct is nothing short of extreme violence against any

human. All the acts of all accused have been deliberate, conscious with full premeditation.

17. That the day-to-day lifestyle of my wife is riddled with fraud, lies and law abuse. This is approved and promoted by greedy and morally deprave Respondent/Accused and built on premise that Vandana Rana, as a lawyer in family would save them from wrongdoings. That my wife misrepresented and defrauded US consulate in receiving US passport with full knowledge of having no consent from me. After refusal from US Consulate due to lack of documentation, my wife intimidate me to strip Atharva of US Citizenship if no consent is given. That my wife, did evade paying taxes in USA and is there a Tax Warrant in her name. that she stole from New York State's funds for unemployment claim for which she was not eligible due to running away to India and thus defrauding the state. That morally bankrupt Respondent/Accused is the psychopathological kingpin and conspirator, directly and indirectly, who very shamelessly continue to promote the wrongdoings.

18. That my wife and Respondent/Accused has even pushed to suicide attempts by saying, "***Ek Kaam karo tum khud ko khatam kar lo***". That time and again she said that, causing immense cruelty upon Complainant.

1. That my wife has solely taken away the child without any custody order or father's consent to India. That please appreciate, because the U.S. and other countries need to ensure a child is not being taken across international borders without parental consent. If one parent will stay behind, that parent should write a letter indicating the name and date of birth of the child or children as well as the name and date of birth of the parent traveling with them, and state that the children are traveling with their knowledge and permission. The parent should then print the letter but NOT sign it, and bring the unsigned



letter to International Student and Scholar Services. Also bring one form of photo id, such as a passport or driver's license. The parent will sign the letter in the office and a notary seal will be affixed to verify the letter comes from that person. Then the parent traveling with the U.S. citizen child should carry this letter with the child's passport when both departing and re-entering the U.S. If neither parent is traveling with the U.S. citizen child, then both parents should write the letter and come to ISSS together to have it notarized. This is the way to travel with a US child across borders, which was not followed by my client's wife.

19. That my wife has wrongfully brought my child to India for the fear of getting arrested in US as there are multiple court orders against her. That since then she has restricted my access by way of calls, messages, meetings on her sole discretion without there being any court order in her favor or restricting my rights as father and natural guardian of Atharva. That the relevant orders against my wife are attached in the above paras No.

20. That on 15<sup>th</sup> May, 2024, I went to meet my son at disbursal time around 12:30 pm at his school i.e. Manav Mangal School, Sector 11 Panchkula. That upon disbursal when I approached to meet my son, the Respondent/Accused - Rajinder Rana started pushing me aside and pulling the bag of my son towards him. That he deliberately knowing that I am his father- natural & legal guardian kept on mercilessly pulling the bag of the child and scuffling with me. That in the said scuffle, he kept on slapping, kicking me hurling abuses in front of my son. That I was shocked and surprised to witness the violence of Respondent/Accused who continuously kept on hitting me and brushing aside my child. That he kept on saying "*maar dunga tuje aj mai*". That he kept on punching me, hurling abuses and taking away my child from a lawful custody of his father and legal guardian.

21. That with the intervention of school authorities, the Respondent/Accused could be pacified. That I was immediately taken to Civil Hospital sector 6 Panchkula, Haryana for my medical assistance. That after checkup, I was given medication and medical treatment for the assault caused by Respondent/Accused. That after gaining strength and sanity, I filed a police complaint before SHO, Sector 10 Police Station, Panchkula seeking registration of FIR for kidnapping, assault, criminal intimidation and other offences by Respondent/Accused.

22. That please appreciate, after the said incident my wife calls us my father and intimidate him of dire consequences if we file complaint against her father i.e. Respondent/Accused.

23. That we have imminent danger to my personal life and liberty at the hands of Respondent/Accused, who is constantly trying to harm me, has harmed me in the past (relevant documents attached) and criminally intimidated me.

24. That I approached the office of the Chief Minister of Haryana, whose political Advisor advised for “*necessary action may be taken in this matter at the earliest*”. That the concerned officers are not moving even an inch in my criminal complaint despite clear cut case of kidnapping from lawful custody of father of the child. That for the perusal of the court, Section 361 is reiterated:

**Section 361: Kidnapping from lawful guardianship.**—Whoever takes or entices any minor under <sup>2</sup>[sixteen] years of age if a male, or under <sup>3</sup>[eighteen] years of age if a female, or any person of unsound mind, out of the keeping of the lawful guardian of such minor or person of unsound mind, without the consent of such guardian, is said to kidnap such minor or person from lawful guardianship.

*Explanation.* —The words “lawful guardian” in this section includes any person lawfully entrusted with the care or custody of such minor or other person.

*Exception.* —This section does not extend to the act of any person who in good faith believes himself to be the father of an illegitimate child, or who in good faith believes himself to be entitled to the lawful custody of such child, unless such act is committed for an immoral or unlawful purpose.

**Section 363: Punishment for kidnapping.** —Whoever kidnaps any person from 1[India] or from lawful guardianship, shall be punished with imprisonment of either description for a term which may extend to seven years, and shall also be liable to fine.

25. That the Complainant has in the past also filed a complaint against Respondent/Accused, Meghna Rana and Champa Rana in Sector 20 Police Station, Panchkula on ..... but nothing has been done in the said complaint till date.

26. That E-mail to US Embassy consulate in Mumbai has been sent by Complaint for international parent child abduction by my wife annexing all relevant documents on.....

27. That the Supreme Court Reiterates: Registration of FIR compulsory upon Disclosure of Cognizable Offence in recently held *Sindhu Janak Nagargoje v. State of Maharashtra*.

28. That the acts of the Kidnapping, assault, physical abuse, harassment, criminal intimidation, took place within the jurisdiction of the Hon’ble Court. It is requested to please register FIR against Mr. Rajinder Rana for offences U/s ..... of Indian Penal code, 1860.

It is prayed that an FIR may kindly be registered and the accused be arrested and brought to the books and tried as per law.

Sir,

I, Arun Kumar Singh, father of Atharva Kumar Singh. My son is US Citizen and is officially kidnapped from USA for 3 years. I found his location at Manav Mangal School as soon as I found him, the individual Rajinder Rana physically assaulted me and ran away with the child again. He being a relative took advantage of situation by causing confusion among school authorities. That after this incident, I was rushed to Civil Hospital Sector-6 Panchkula for medical attention. That thereafter I filed Police Complaint before Sector 10 Police Station seeking registration of FIR and arrest of Rajinder Rana attaching all my medicals.

That I have filed the complaint on 15<sup>th</sup> May 2024 and requested concerned police to obtain CCTV footage of the incident but there has been no action from the side of the police officers till date.

That I am requesting with folded hands that a FIR may be registered, and immediate arrest may be made against Mr. Rajinder Rana for his attack upon me outside the school of my son. He is not the authorized legal guardian of the child.

It is prayed that an FIR may kindly be registered and the accused be arrested and brought to the books and tried as per law.

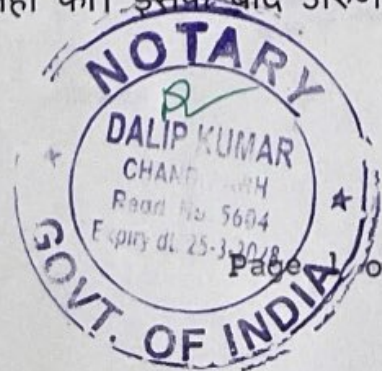

मेरा बयान, नाम Ravinder Singh, पुत्र Gursharan Singh, निवासी Khizrabad West, Barsalpur (141), Kharar, Sahibzada Ajit, PB 140109.

मैं आज आपके सामने पूर्ण सच के साथ देते हुए आपके सामने लिखित बयान दे रहा हूँ। मैं उपरोक्त पते का रहने वाला हूँ और और Vaishnav Bouncer Services एजेंसी का एक सुरक्षाकर्मी हूँ। मुझे एजेंसी से जैसे काम दिया जाता है और जिसके लिए भेजा जाता है वैसे ही लोगो को सुरक्षा देने का काम करता हूँ। मुझे Vaishnav Bouncer Services की तरफ से अरुण कुमार सिंह की सुरक्षा के लिए कुछ दिनों के लिए भेजा गया था और मैंने अपनी जिम्मेदारी से हमेशा साथ रहकर अपनी ड्यूटी को निभाया था। मेरा अरुण सिंह के साथ कोई व्यक्तिगत या पारिवारिक संबंध बिलकुल भी नहीं है और ये मेरा पूर्ण और निष्पक्ष बयान है। मैं पूर्ण रूप से सिर्फ एजेंसी की तरफ से काम करता हूँ, और कोई अरुण सिंह जी का कर्मचारी नहीं हूँ।

जैसा मुझे ज्ञात हुआ था कि अरुण सिंह जी खुद को किसी रजिंदर राणा और उसके परिवार से खतरे में रहते हैं, मैंने उन सक्श के बारे में कुछ नहीं जानता। दिनांक 15 मई 2024 को, मैंने अरुण जी के साथ मानव मंगल स्कूल में गया। वो अपने बेटे से मिलकर उसे एलांटे मॉल में घुमाने ले जाना चाहते थे। स्कूल में बच्चों की लाइन लगी हुई थी। जब अरुण सिंह का बेटा दौड़ते हुए आया और जब उन्होंने उसे अपने हाथों से दोनों तरफ प्यार से पकड़ा तो एक बड़ी उम्र के व्यक्ति, जिसका बाद में मुझे पता चला कि वही रजिंदर राणा हैं, उन्होंने बच्चे के बस्ते को जबरन पकड़ और उसके अपनी और घसीटने लगे। इस पर अरुण सिंह जी ने कई बार कहा कि "मेरा बेटा है ये" फिर भी रजिंदर राणा उस बच्चे को जबरदस्ती बस्ते को पकड़ कर अपने तरफ खींचते रहे। इसके बाद रजिंदर राणा ने अरुण सिंह जी को जकड़ लिया और बच्चे से दूर धक्का मारने लगे जिससे वो अपने बेटे तक ना पहुँच सकें। इसके बाद रजिंदर राणा ने घूसों से अरुण सिंह जी पर लगातार मारते रहे। अरुण सिंह जी को दीवाल पे धक्के से चिपका दिया। रजिंदर राणा ने फिर अरुण सिंह का गला और कॉलर पकड़कर कई बार कहा "मार दूंगा तुझे आज तो"। तब तक शायद उन्हें ये पता नहीं था कि अरुण सिंह एक अंगरक्षक को लेके आय हैं। मैंने तब तक कोई अपनी तरफ से प्रतिक्रिया नहीं की। इसके बाद अरुण सिंह के बेटे को हाल में किसी तरफ से

"Maar Dunga Tyjhe" which was heard by people around me. After punching me hard he pushed me against the wall. He is NOT a legal guardian nor have any authority over the child. He has been keeping the child hidden from me. He has no rights and whatever happened in Manav Mangal today is a blatant act of kidnapping and criminal assault. I suffered pain severely in my chest, I was short of breath and hurting from back pain due to being pushed against the wall. I would like to remind that many complaints have already been filed against Randeer Rana and matters about his harassment and kidnapping has been brought to your attention and Panchkula court, High Court at Chandigarh, ministry of law and justice. No action was taken previously. Now the incident of kidnapping and brutal assault and threat to kill me occurred in full view in camera recording with dozens of witnesses. No legal guardian can be subjected to this kind of brutality and physical



trauma and harassment. How can a non-parent individual who is known for his wrong doings can prevent me from having my son when I have full legal authority as ~~my~~ my son's legal guardian by Indian law as well as laws of United States who the child is a citizen of. I am an Indian citizen.

My chest was not shaking my heart and rib cage and I had to rush to civil hospital in sector-6. I was fainted, suffering from physical pain as well as depression and psychological trauma. I am admitted to hospital and sending this FIR and arrest Rajinder Rana immediately. Please take action for this complaint along with previous complaint.

Due to ~~the~~ threats posed to my life I had to hire personal security. That was the reason I am alive today. My personal security intervention <sup>and further</sup> stopped Rajinder Rana's assaults. I cannot
