


SUMMARY OF ALL RELATED CASES WITH SAME PARTIES

Case # 5 Dec 2023	Dissolution of Marriage with Dependent Child	Arun K Singh Vs Meghna Rana	Family Court of St. Johns County, Florida, USA	Granted	The marriage was dissolved, and since there was a minor child involved, a fresh custody order issued granting SOLE custody AGAIN to the Petitioner.
