

HISTORY OF CHILD HEALTH AND SAFETY ABUSE

CHILD CUSTODY CASE Arun K Singh Vs Meghna Rana File # 26453 Docket #V-00234-22




- One of the key reason for argument in marital life was Meghna ignoring child health and safety repeatedly.
- Meghna's autocratic way to raise the child has put the child's physical, mental and emotional well being in danger numerous times.
- During a work related trip to Florida in summer of 2019, Meghna once lost the child. The child was found hours later and Tammy Gajeswki, front desk manager commented that the child being lost was Meghna's fault as it was her responsibility to keep the child safe.
- Meghna claims she has been most actively engaged in raising the child but she ignores to take responsibility slow mental growth of the child while in her supervision.
- Meghna had the child removed from the school he was studying to participate in her father's collusion to extort funds and to be sent to India.
- Meghna had the child moved from one school to another in India, for apparently one school being "too expensive" when she spent a miniscule amount of funds available to her on the child.
- Under influence by Meghna's law abusing father and during peak of COVID, Meghna had the child travel internationally, across the world, exposing the child to dangers posed by such travel.

- Meghna's refused to get fully vaccinated against COVID for months despite traveling to gym, markets, school for the child on daily basis. Meghna's law abusing father shows no regards or concern for the well being and safety of the child.
- Meghna, in her autocratic and abusive style, under the influence of her law abusing father, denied the child full parental rights to the child.
- In a blatant act of perjury and cruelity, Meghna's received order of protection and used that as a pretext to kidnap and run away with the child, foreseeing financial difficulties in business affairs.
- Meghna perjured in saying she was caused 'obstruction of breathing' and then again perjured in saying 'child was hurt', among other falsehoods. Requesting court to look at evidences supplemented with polygraphy/lie detection.
- December 14th 2021, after a phone conversation with very corrupt Rajinder Rana, Meghna's father, passed a judgement, like a supreme judge and had me blocked from all communications with Meghna and my child. My fault apparently not being respectful enough after aiding and abetting my child's kidnapping. Communication was only established on 14th Feb 2022, full 60 Days after the phone call.




- Rajinder Rana, seemingly intoxicated with the power of his criminal (lawyer) daughter in a country with all pervasive corruption, exerted detrimental impact to the breaking point, on institution of marriage and all round development of child.
- The child is being held captive, as a measure to secure more and more funds, against my wishes and approval.
- Last immunization on record for the child was 20th Feb 2020 when the child was under his father's supervision. Requesting court to ask Meghna for record of immunizations after that date when the child was in her direct supervision and control.
- In one of Shocking instance, Meghna proposed to abandon the toddler, under care of her law abusing father, and resettle in Canada, at my expense, for further studies, leaving the child stranded in no care of either of his parents. It's highly likely Meghna would abandon the child in future, just like she abandoned her husband and a struggling business.
- Only after the filing of court case for child custody, Meghna sought after record of immunization history of the child, end of March 2022, full 11+ months after moving the child abroad.




- Meghna has been driving the child almost on a daily basis without using seat restraints in India.
- Meghna forced me to accept her driving time as the only time many times she could accept calls as she cannot speak in front of her parents.
- Apparently Meghna, without job, without any sense of purpose and no other huge responsibilities on her shoulders was too busy to find any other suitable time to have video calls.
- I insisted many times to not drive and make video calls, which by habit, Meghna summarily rejected and repeated her actions multiple times.
- Under my supervision, Atharva was never in a car without child restraint. Meghna immediately ignored those lessons of safety while in India.
- Meghna continues to pose danger to Atharva's safety even to date by not changing any habits.



MID OFFICE ACCIDENT DUE TO NEGLIGENCE CHILD'S BROKEN NOSE AND HEAD INJURY

Recorded Incident 01:

10th Feb 2021 - In mid office of the hotel, despite numerous objections in past by the petitioner, meghna's ignored child safety advices and placed the toddler on a swivel chair and left him unattended. Child fell from the chair, beaking his nose and bleeding. Petitioner rushed the child to medical care immediately.

There had been numerous arguments in past with Meghna regarding her ignoring child safety, they all fell on deaf ears.

LOSING THE CHILD DUE TO NEGLIGENCE

Recorded Incident 02:

- During summer of 2019, petitioner was his official visit to Florida and child was left in Meghna's care.
- Meghna lost the child and called the petitioner over the phone.
- Petitioner mobilized his entire staff to find the child in the hotel.
- Hours later the child was found, who seemed to have wondered outside hotel due to Meghna overlooking the child.
- Then Front Desk manager, Tammy Gajewski placed the responsibility entirely upon Meghna, and should be interviewed for the incident.
- Whichever parent is in charge of the child, should be responsible to the safety and security of the child.
