I, Meghna Rana, residing 'at 3025 Rt 426 Findley Lake NY 14736, by this Supporting Deposition make the following allegations of fact in connection with an accusatory instrument filed, or to be filed, with this court against the above named defendant:

I Meghma Rana state the following on my own free will and to the best of my knowledge. On April 8th 2021 at around 2:40 pm I was in the bathroom behind the front desk. My husband Arun Singh is the owner of the Hotel and we live at the hotel. I was in the bathroom combing my hair and when I went to leave Arun was standing outside the door when I opened it. He then grabbed me by my hair and threw me on the ground. Arun then started to punch and kick me all over. He hit me several times in the head and arms. I was using my arms to try to stop him from hurting me. Arun then put his knee on my neck and held me down on the ground. I could not breathe when he was on my neck. I kept telling him to stop but he wouldn't. Finally he got off and I was able to run out of the bathroom. Arun also threatened to kill me my family and my son. I am fear full that he will try. My left side of my head is in a lot of pain and my left ear. My neck is very sore and I have been dizzy ever since. I have a bump on the left side of my head. Arun has been very violent with me over the last four years. I can't do this anymore so when Arun left the hotel I called the police. I would like Arun arrested and charged to the fullest extent of the law. I also would like an order of protection against Arun to protect me and my son.



On 08.04.2021, he broke all limits & stepped on to the chest of the answering respondent in order to kill her & kept yelling and shouting that he will kill the answering respondent & their only child too. Somehow with great force answering respondent managed to turn around and saved her life and called the cops. 
PREJURY AND MENTAL TORTURE - CHANGING STORY

Evidence 02: It should be noted that two domestic incident reports were filed, within 24 hours. First incident report was filed with Officer Dana Kapuscinski afternoon of April 8th 2022. MEGHNA contacted one of hotel staff to reach out to me that she is abandoning hotel overnight, and I should immediately take over. Hotel is where I was living at the moment and is also my place for business. Meghna tricked me and when I arrived, she again called police and filed second incident report with Officer Daniel Hanson.

PREJURY AND MENTAL TORTURE - INCONSISTENT STATEMENTSS

Evidence 03: For the question of if I EVER threatened to kill her or children, Meghna responded affirmative to Officer Kapuscinski while she responded with negative to Officer Daniel Hasson.

Evidence 04: For the question of if I EVER strangled or choked her, Meghna responded with affirmative to Officer Kapuscinski while she responded with Negative to Officer Daniel Hasson.

Evidence 05: For the question of if I had EVER beaten her while pregnant, Meghna responded with affirmative to Officer Kapuscinski while responding with Negative to Officer Daniel Hasson.

PREJURY AND MENTAL TORTURE - INCONSISTENT STATEMENTSS

Evidence 06: For the question of if I am capable of killing her or the children, Meghna responded with affirmative to Officer Kapuscinski, while responding with Negative to Officer Daniel Hasson.

Evidence 07: For the question of if I am violently and constantly jealous of her, Meghna responded with affirmative to Officer Kapuscinski, while responding with Negative to Officer Daniel Hasson.

Evidence 08: For the question of if the physical violence has increased in frequency or severity over the past 6 months, Meghna responded with affirmative to Officer Kapuscinski while responding with Negative to Officer Daniel Hasson

PHYSICAL INJURY TO PETITIONER

Evidence 09: For the question if the suspect injured, the notation was made as no. Which is incorrect, I was not at the scene when Meghna was giving her statements, I did have injury to my hand which I showed to the officer when I arrived at the scene. The bias against men completely disregarded my injury.

LIER'S DISTATSTE FOR POLYGRAPHY

Evidence 10: I am offering myself to a polygraph test about the obstruction of breathing charges and all the questions Meghna answered to officer Kapuscinski Vs Officer Hasson. Meghna is going to refuse to do the same. If there is any element of doubts in above evidence about the truth, the polygraph should bridge the gap. It should be equally conducted for Meghna and as well as for myself.

- Meghna refuses to submit herself to polygraphy that I caused obstruction of breathing
- Meghna refuses to submit to polygraphy that I said anything about killing the child
- Meghna refuse to submit to polygraphy that she did not cause any physical harm to child
- Meghna refuse to submit to polygraphy that she did not cause any physical harm to myself

NO PHYSICAL INJURY TO MEGHNA

• Evidence 11: Despite purported injury to her neck, after display of some acting, she had no trouble breathing or giving any statements to officers, she was not admitted to hospital, she had no real physical injuries. In the report her physical injury was described as he face being red, which she always had when angry.

FLEEING THE COUNTRY TO AVOID CONSEQUENCES

• **Evidence 12**: After filing her fake complaint, Meghna quickly left the country avoiding any consequences, and never cooperated in the case. She refused to even speak with prosecutors and did not respond on phones or emails.
